United States Citizenship and Immigration Service (USCIS) regulations require documentation that sufficient financial resources are available to meet a student's prospective educational and living expenses while in the U.S. Therefore, Oklahoma State University-Oklahoma City requires a guarantee of financial resources from each applicant who expects to obtain or maintain Student (F-1) status. Applicants are required to submit financial documentation that equals or exceeds one full year of educational and living expenses. A Certificate of Eligibility (I-20) will not be issued until this information is provided. **An original bank statement dated within the last six months showing the total estimated funds is required in addition to this form.**

ESTIMATED EXPENSES

The amounts listed below are estimates and are subject to change without notice. Historically, total costs have increased on an average of 5-10% each year. Students can expect adjustments in the amounts listed on the Certificate of Eligibility (I-20), which will reflect estimates for the upcoming year. This estimate is based upon 12 semester hours each semester for nine months. OSU-OKC scholarships are not available to international students.
