- Provide a copy of your **Certificate of Eligibility** (COE) to the Veterans Services office unless you are using Chapter 31, VR&E Benefits. Your COE is required to process your Certification Request. Chapter 33, Post 9/11 GI Bill® students may provide a Statement of Benefits in lieu of a Certificate of Eligibility which can be downloaded as a PDF from the VA website. https://www.va.gov/education/gi-bill/post-9-11/ch-33-benefit/. If you have used your Education Benefits previously, you are required to submit a Change of Training form to the VA available on the VA website. https://www.va.gov/education/change-gi-bill-benefits/
- Request a copy of your Joint Services Transcript from the JST Website- https://jst.doded.mil/official.html, if applicable, to be evaluated by OSU-OKC for prior credit.
- Enroll in Courses that are required for your degree or program. Full-time enrollment status is required to receive maximum benefits. To schedule an appointment with your Advisor, go to https://osuokc.edu/advisement/staff.
- Complete and submit a Request for Certification form to the Veterans Services Office each term of enrollment at OSU-OKC. Email the completed form to okc.va@okstate.edu or submit the form in person at the Registrar Services Window in Student Services.
- Keep your OKEY account active and check your okstate email often to address issues that can affect your benefit payments. Keep changes in contact information (mailing address, email address, phone number) up to date in myOKSTATE Self-Service to avoid delays in processing your benefit payments.
- Report changes in enrollment (adds/drops/withdrawal from OSU-OKC) by email from your OKSTATE email account to okc.va@okstate.edu or by completing and submitting an updated Certification Request form.
- Notify the Veteran Services Office if your VA Education Benefit changes by emailing okc.va@okstate.edu.
