



2024-2025 Student Health Insurance Plan: Oklahoma State University

Who can enroll?

All international and English Language Institute students taking one (1) or more credit hours are required to purchase this insurance plan and the premium for coverage is added to their tuition billing. International J-1 Scholars actively participating in course work or research activities, and Visiting Faculty/Scholars, are required to enroll in this insurance plan. Study Abroad and PAVE students are eligible to enroll in this plan. Dependents of those enrolled in the plan may participate in the plan on a voluntary basis.

Eligible students who do enroll may also insure their Dependents. **Eligible Dependents are the student's legal spouse and dependent children under 26 years of age.**

The student (Named Insured, as defined in the Certificate) must actively attend classes for at least the first 31 days after the date for which coverage is purchased. Home study, correspondence, and online courses do not fulfill the eligibility requirements that the student actively attend classes. The Company maintains its right to investigate eligibility or student status and attendance records to verify that the Policy eligibility requirements have been met. If and whenever the Company discovers that the Policy eligibility requirements have not been met, its only obligation is refund of premium.

Student Health Center Benefits:

- The Deductible will be waived and benefits will be paid at 100% for Covered Medical Expenses incurred when treatment is rendered at the Student Health Center for the following services: Prescription Drugs at the SHC after a \$10 Copay for Tier 1 Prescription Drugs and a \$25 Copay for Tier 2 Prescription Drugs up to a 31-day supply per prescription. Policy Exclusions and Limitations do not apply.
- The Deductible and Copays will be waived and benefits will be paid at 100% for Covered Medical Expenses incurred when treatment is rendered at the Student Health Center for the following services: all other services listed in the Schedule of Benefits.
