BRIGHT FUTURES PROGRAM REQUEST

The OSU-Oklahoma City Bright Futures Program is geared toward incoming freshmen who are eligible for Oklahoma's Promise funding. This program will supplement Oklahoma's Promise by providing additional financial assistance for fees and book assistance. Funds are limited; therefore, funding will be provided on a first-come, first-served basis.

CRITERIA FOR ELIGIBILITY:

- 1. Student must be admitted as a first-time freshman and enroll at OSU-Oklahoma City.
- 2. Student must be pursuing an OSU-OKC degree.
- 3. Student must be an Oklahoma's Promise recipient.
- 4. Student must enroll for a minimum of nine credit hours fall and spring semesters.
- 5. Eligible students will receive OSU-OKC Bright Futures assistance for three academic years.
- 6. Bright Futures recipients may enroll for up to six credit hours in summer sessions.
- 7. Student must complete a minimum of nine credit hours and maintain a 2.5 cumulative grade point average.
- 8. Student must complete and submit the Bright Futures Program Request.
- 9. Student must complete and submit the Free Application for Federal Student Aid (FAFSA) to the US. Department of Education for eligibility consideration.

An official copy of the high school transcript and ACT scores (as applicable) must be attached to this application when submitted to the Financial Aid and Scholarship Office.
