



Annual Staff Evaluations Due May 31st

It's time for Annual Staff Evaluations. You will receive an email notification once your supervisor has assigned the evaluation. To locate your performance evaluation, log in to the Talent Management System (TMS, formerly LMS). From the home page, click on *Performance*.




You will see your self-evaluation for 2024 listed under *My Assigned Reviews*. Be sure to complete every question and submit the evaluation so your supervisor will be able to view your answers.

Health Savings Account Transition

OSU A&M's benefit plan includes a Health Savings Account (HSA) Option for those enrolled in the BlueEdge High Deductible Health Plan.

Currently, the HSA is administered by Benefit Wallet. On Friday, May 10, all OSU A&M HSAs will automatically transfer to HealthEquity, an IRS-approved non-bank custodian.

If you have elected to contribute to your HSA, payroll deductions will continue into the HealthEquity account.

Summer Catapult Health Screenings

Appointments are available for Catapult screenings on OKC Campus

Summer 2024 Clinics: July 17th (Wednesday) July 18th (Thursday)

Schedule a time for your Catapult health screening.

Catapult conducts free, confidential health screenings on the Stillwater campus for your convenience. The screening consists of a diagnostic blood test, measured biometrics, family medical history and a personal health report. Catapult health screenings are available for employees and their covered spouses enrolled in one of the OSU BlueCross BlueShield health plans (BlueOptions or BlueEdge). New hire benefits must be effective prior to the health screening appointment. Employees who complete the Catapult screening receive a \$30/month health plan premium credit, effective the first of the month following the screening. As a reminder, premium credits for screenings completed after

July 1 begin the first of the following month and continue through December 2024.

New in 2024, Catapult will be going to a 100% Tasso clinic model. Benefits to this clinic model include:

- Eliminated the experience of a painful needle finger prick! ·
- Takes only 10-15 minutes to complete your blood draw and measurements vs. 40 minutes.
- Complete your NP consultation from the privacy of your home and at a time that works best for you.
- A1C measurement for all participants.

Benefits Minute: Preventive Care

Did you know that many diseases and conditions can be prevented through early detection? With preventive screenings, you are taking steps to track your health in hopes of avoiding chronic conditions before they become more serious.

Employees on OSU's BlueCross BlueShield Health Plans are eligible for preventive health screenings covered at 100% when using an in-network provider.

Preventive services include, but are not limited to:

- Well Child Exams
- Well Woman Exams
- Immunizations
- Screening tests, such as blood pressure, cholesterol, or depression
- Cancer Screening, such as colorectal or breast cancer
- Health Counseling

As a reminder, if you complete a preventive screening through <u>Catapult</u>, you will receive a \$30/month health plan premium credit.
