INCOMPLETE GRADE:

The grade of "I" represents incomplete work. It may not be used as a substitute for a failing grade. The request for an "I" grade is initiated by the student and granted to eligible students at the discretion of the instructor. In order to be considered for an "I" grade, a student must have successfully (grades above passing) completed at least 70 percent of the course work and be unable to finish for reasons beyond his or her control. In order to award a grade of "I," the student and the instructor must complete an [Incomplete Grade Contract](#) form. The "I" grade agreement sets the conditions for the satisfactory completion of the coursework and is submitted by the instructor to the office of the registrar.

WITHDRAWING FROM ALL CLASSES:

WITHDRAWING FROM ALL CLASSES –FEDERAL AID RECIPIENTS:

All federal aid recipients who completely withdraw from school prior to completing at least sixty percent of the semester will have to repay some portion of the federal funds received. OSU-OKC will determine the unearned portion of the funds received. This refund policy may require the student and/or the university, on behalf of the student, to immediately pay funds disbursed for the purpose of paying educational cost. **The student will be held responsible for any funds the university is required to return on the student's behalf to the federal program.** Payment arrangements will be made through the Bursar's Office only.

ADMINISTRATIVE WITHDRAWAL:

EMERGENCIES ON CAMPUS:

In case of an emergency: Contact Campus Security by dialing (405) 945-9111. Security officers will determine if any outside agencies (fire department, police department, paramedics, etc.) need to be contacted, and do so as the need arises.

Emergency messages: These messages are often received for faculty, staff and students. All attempts are made to deliver messages deemed to have urgency. The least interruption possible is the goal, but, if necessary, an emergency message will be delivered to either a student or instructor during class. Caller must be able to provide valid emergency information before a message is delivered.

TOBACCO AND VAPING:

OSU-OKC is a TOBACCO and VAPOR FREE campus: No tobacco products including but not limited to cigarettes, cigars, pipes and smokeless tobacco or smoking preparations including but not limited to hookahs, electronic cigarettes, vapor devices, and clove cigarettes are allowed on OSU-OKC property or in classrooms, buildings or vehicles. In addition, tobacco products, vapor cigarettes, e-cigs, etc. are not allowed during Fieldwork assignments on the OSU-OKC campus or at community-based sites when completing OSU-OKC required Observation / Fieldwork.

ELECTRONIC DEVICE POLICY:

Cell phones and other electronic devices are disruptive to the class. If a student's work or family situation requires the student to keep the device turned on during class, the student must turn the phone to a silent or vibrate mode. If a student must receive a call during class, the student will leave the room. A student may not make a call during class. Cell phones and all electronic devices may not be used during an exam unless stipulated by an instructor. Use of a cell phone or electronic device during an exam is considered academic misconduct, and the student will be subject to the appropriate penalties. This policy may be strengthened by the instructor.

UNATTENDED CHILDREN POLICY:

For personal safety of children and potential problems in supervision, children should not be at any location on campus without adult supervision. No children are permitted in classrooms, laboratories, teaching areas, or the library.

STATE QUESTION 788 and MARIJUANA ON CAMPUS:

Oklahoma State University (OSU) and The University of Oklahoma (OU) receive federal funds, and the two institutions are legally bound to comply with the Federal Drug-Free Schools and Communities Act (DFSCA), which mandates the implementation of drug prevention programs and prohibits the use of illegal drugs on campus or at University-sponsored events and activities. The universities must also comply with the Federal Drug-Free Workplace Act, which describes the drug-free policies required at workplaces with certain federal contracts.

Furthermore, the two Universities must also comply with the Federal Controlled Substances Act (FCSA), which criminalizes the growth and use of marijuana.

Despite the passage of State Question 788, the DFSCA requires OSU and OU to adopt and adhere to policies prohibiting the unlawful use, possession, or distribution of illegal drugs, including marijuana. Moving forward, OSU and OU will adhere to federal law prohibiting the use, possession, distribution, or cultivation of marijuana for any reason at their campuses across the state. Additionally, federal law also prohibits the use and distribution of marijuana for any reason at events authorized or supervised by OSU and OU. Even with the evolving state law permitting marijuana use for medical reasons, it is important for students and employees to know they cannot consume, smoke, or possess marijuana on campus even though they might have a card or prescription permitting them to do so.

GENERAL EDUCATION GOAL STATEMENT:

Upon completion of an OSU-Oklahoma City degree, students will have accomplished the following five outcomes:

1. **Critical Thinking:** *Students solve problems by evaluating arguments or propositions and making judgments that guide the development of their beliefs and actions.*

Critical thinking skills include, but are not limited to, the ability to comprehend complex ideas, data, and concepts; to make inferences based on careful observation; to make judgments based on specific and appropriate criteria; to solve problems using specific processes and techniques; to recognize relationships among the arts, culture, and society; to develop new ideas by synthesizing related and/or fragmented information; to apply knowledge and understanding to different contexts, situations, and/or specific endeavors; and to recognize the need to acquire new information.

2. **Effective Communications:** *Students communicate effectively using organized and coherent written and oral presentations appropriate for the audience and situation.*

Effective communication is the ability to develop organized,

coherent, unified written or oral presentations for various audiences and situations.

3. **Computer Proficiency:** *Students use computer and network technologies to gather, analyze, and communicate information.*

Computer proficiency includes a basic knowledge of operating systems, word processing, and Internet research capabilities.

4. **Civic Responsibility:** *Students engage in the community through activities effecting positive change in society and the environment.*

Preparation for civic responsibility in the democratic society of the United States includes acquiring knowledge of the social, political, economic, and historical structures of the nation in order to function effectively as citizens in a country that is increasingly diverse and multicultural in its population and more global in its view and functions.

5. **Global Awareness:** *Students display sensitivity to cultures across local, national, and global communities.*

Global awareness includes knowledge of the geography, history, cultures, values, ecologies, languages, and present-day issues of different peoples and countries, as well as an understanding of the global economic, political, and technological forces which define the interconnectedness and shape the lives of the world's citizens.

GLOBAL EDUCATION MISSION:

Global Education is an institutional commitment to providing learning environments that provide a cross-cultural global perspective through all facets of the educational process. This institutional commitment to Global Education shall manifest itself throughout the entire institution, providing support for diversity, international, and inter-cultural educational opportunities. These opportunities will be institutionalized through curricular and co-curricular activities. This institutional commitment to Global Education will assist OSU-Oklahoma City in accomplishing its mission of preparing students for an increasingly technological and global society.

TECHNOLOGY REQUIREMENTS:
